Introduction

To address the energy challenges faced by the Tunisian energy system, Tunisia has committed to a medium and long-term energy transition policy based primarily on enhancing energy efficiency and developing renewable energies.

The "Prosol Elec Economique" Program is part of this strategic vision and aims to encourage the use of photovoltaic solar energy for self-production of electricity. The "Prosol Elec Economique" Program aims to reduce public subsidies granted to the electric sector and to combat energy poverty among households with low electricity consumption and consequently low to medium income.

In addition to the contribution from the Energy Transition Fund "FTE" of 4.5 million euros, this program will benefit from financing from the Mitigation Action Facility "MAF" through a grant of 10 million euros.

The side event serves as a privileged platform for the official announcement of the launch of the "PROSOL ELEC Economique program". This event will also be an opportunity to highlight the vital importance of national and international partners, whose support and commitment are essential for the implementation and success of this ambitious initiative.
